

DAC evaluation criteria


- Relevance To what extent is the activity suited to priorities and policies of the target group and development partners?
- Effectiveness To what extent are the objectives attained?
- Efficiency To what extent were the least costly resources possible used to achieve the desired results?
- Impact What are the positive and negative changes produced, directly or indirectly, intended or unintended?
- Sustainability To what extent will benefits likely continue?

Why We Are Consulting

The DAC Evaluation Criteria are widely used by many organizations and actors in the evaluation of development programs. They are currently reflected in policies, manuals and in the terms of reference in a wide range of individual evaluations by development ministries, agencies, banks, partners, NGOs, etc. They consequently have a strong influence on current evaluation practice.

However, after 15 years of applying these evaluation criteria, we believe it is time to revisit, or at least have a discussion on, whether they are still relevant.

We are mainly asking three questions.

- 1. What should we keep as is?
- 2. What should we change or adapt?
